COACHES! 101 A NJ NON-PROFIT

Coaches! 101 A NJ Non-Profit Organization

This non-profit organization is a legal entity comprised of three different parts, and with two departments operating under the same tax ein number. The parent company is the legal entity that will do all of the following.

- Notary Services
- Business Set up
- Legal Services

Notary Services: Coaches! 101 A NJ Non-Profit Organization through our notary specialists can certify legal documents such as deeds, writs, contracts and any other documents that need to be authentic and have a witness. Our notary public is Omar Dyer; who is a public officer appointed by the state of New Jersey to help prevent fraud. Omar Dyer handles any and all document for legal representation, and will not witness power of attorney. Omar Dyer has a Masters in Legal Studies, and has been a notary public for 12 years.

1. Part of the services that are provided by our set up program:
 - a. Consultation: To inquirer about specific government services, and referrals to other agencies – this service is free of charge.
 - b. Notarizing documents: The state of New Jersey, requires a payment of \$5 to \$25 for documents to be notarized. This service is a fee adapted service that pays the notary directly, none of the funds during the session or timing is paid or donated to Coaches 101 A NJ Nonprofit.
 - c. Specialized Witness, this service is based upon request and demand approval, and fees are subjected to the price of the notary.
2. Notary: Any notary that volunteers or is employed by Coaches 101 A NJ Nonprofit is an independent contractor, and the consultation of the service is free; payment is optional based on the notaries discretions.

Business Set Up: Coaches! 101 A NJ Non-Profit can help with organizing a structure for a business plan, with organizational formatting for corporations; board formalities for limited liability partnerships, or companies. We can provide assets evaluations for potential investors or bank loans. Coaches! 101 A NJ Non-Profit can help with organizing a foundation, regrouping a trade; prepare documents for state and federal monitoring systems. Plus give you consulting on drafting By-laws and Privacy statements.

Coaches! 101 (Political Action Committee)

Coaches 101 (PAC) is a separate entity in it's entirety with a separate filing process with the IRS as a 527 Organization. This wing of the company is politically active in both local and state as an advocacy group that is comprised of employees and volunteers from Coaches 101 A NJ Non-Profit.

The My Plan Challenge Foundation Fund: This foundation was created to promote awareness with humanitarian issues in the United States of America with political activities. There is a set of by-laws for this for this foundation which has dual representation from the 527 Political Organization and the Private Foundation of Coaches 101 A NJ Non-Profit.

GOTV Campaigns: Get out the vote campaigns on social media are a very growing and conclusive way to engage voters. The 527 political organization which has connections to Coaches 101 A NJ Non Profit will engage in politics with employees from the private organization.

Voter Registration: As a separate connected organization, employees from Coaches 101 A NJ Non-Profit will engage in voter registration drive in hopes to engage in political discord.

Coaches 101 (PAC) is a charitable organization as a 527 political organization, which the members of this connecting organization are employees of Coaches 101 A NJ Non-Profit. Members of the action committee which follows the rules and regulations from the Internal Revenue Service Political Organization department, and the FEC: Federal Election Commission; are not employees of the 527 political organization.

Coaches 101 A NJ Non Profit Mission Statement Explanation

Coaches 101 A NJ Non-Profit applied for exemption status and requested that the IRS determine the status of the company. The reason for the request is because we wanted to be accurate in our application process, when we file as a private foundation. Included in this document are the by-laws of the company, and the by-laws of the foundation the company and it's connected organization is setting up.

Please note that this company has a Board of Trustees, which is required by the state of New Jersey in order to set up the Articles of Incorporations. The Board of Trustees, are next of kins who don't participate in the daily operations of the company. The Board Of Trustees are organized as a measure to ensure that the company's rights to do business has a liquidation process just in case the founder and legal representative of the company has been deceased.

Omar Dyer is the founder of the company and is responsible for the day-to-day operations of the company. Coaches 101 A NJ Non Profit, uses the terms of legal representative in the case of Omar Dyer based on filing purposes. Omar Dyer is also the registered notary public and tax professional with the company. And Coaches 101 A NJ Non Profit came to the conclusion to leave executive roles within the company open during this phase. Example: The CEO of the company is vacant until further notice, the title President of the company is vacant until further notice, and any other executive title are currently vacant as we organize this process.

Coaches 101 A NJ Non-Profit, was formed in 2007 but has been inactive from 2007 until 2010, based on the notion of having zero employees and zero revenue. The parent company had no financial activity and was merely a hub to hold license and certifications for Omar Dyer. Omar Dyer is a writer, blogger and social media influencer. Currently, Omar Dyer has business accounts with Facebook, Twitter, TikToc, Go Fund Me, PayPal, and other non-profit or charitable organization donation pages.

- A. Mad Comedian Brand: We are including a business resume of all of the connections we have in the corporate world that is included in our company profile.
 - a. Mad Comedian Brand has a current service mark in the State of New Jersey to sell goods and to raise funds for "The My Plan Challenge Foundation Fund."
 - i. Mad Comedian Brand currently has trademark and service mark applications pending with the US Copyright and Trademark office.
 - ii. Mad Comedian Brand has two webpages that allows consumers to purchase gear and goods, and all proceeds from the purchased goods are recorded on the transcripts of Coaches 101 A NJ Non-Profit's accounting.

 - b. Our organization: Coaches 101 A NJ Non Profit does offer legal services and business setup as described above.

- B. All activities that are monitored and conducted are performed by Omar Dyer at this current time, all other day to day business operations are currently vacant or suspended. The organizational set up of the Board of Trustees are for the notion of retaining the legal rights of the parent company, and asset protection.
- C. Coaches 101 A NJ Non Profit is a homebased business at this current time with the physical address of 275 Liberty Ave Apt: 2 Jersey City NJ 07307, and mailing address of PO Box 4463 Jersey City, NJ 07304. Our future plans are to build an corporate facility and build on the brand of Mad Comedian.
- D. These activities are conducted on around the clock and done yearly via on social media platforms.
- E. Coaches 101 is the type of foundation that is always soliciting patrons for funds and the work is done yearly.
- F. The activities of the Mad Comedian Brand and The My Plan Challenge Foundation Fund is open to residents of the United States, and with future plans of foreign interactions with TikToc; to where all is open to engage.
- G. Coaches 101 via social media will run targeting advertisements to selected places and cities.
- H. There is a fee for these transaction, and the fees are exclusive to the social media platform. The prices and determinations are subjected to the fees and regulation on those individual platforms. But for example: we may charge a \$9.99 subscription fee.
- I. To engage on these social media platforms a trade must present a US IRS approved 503 (C) exemption letter because 100% of the transactions will be charitable donations.
- J. The percentage of the funds are recorded as administrative cost and it will be 100%
- K. The time spent on these activities are at 55% of Omar Dyer's time and 45% of the time not spent is due to outside income.
