The company in the year of 2022, officially took over the My Plan Challenge and turned it into two programs. One program is the My Plan Challenge Foundation Fund, which has two components to the program, and the My Plan Challenge initiative. Our program that is a part of the My Plan Challenge Foundation Fund, raised \$112,887, for programs like Bruh: "YOU DIDN'T KNOW I AM THE JOKE."

During this year, our organization faced some challenges, where as the organization officially filed with the United States' Tax Court to prevent the publication of a document that lead to Coaches 101 A NJ Nonprofit filing a complaint on the Internal Revenue Service. Our programs, during this year has been on automatic—where much of the program has been temporarily suspended and go through general administrative duties

During this year funding cap, the organization was able to adhere to restrictions from the SEC. We filed state licenses for BYDKIATJ franchise. The program became our inclusive with Instagram, and building a audience with the platform.

Coaches 101 A NJ Nonprofit, has a level of standards when it comes to crypto currency. As part of the Profit-sharing and Angel Investor's program—which requires a call option, a call put, a promissory note, and a waiver which allows in-kind donations.

Due to the nature of the complaint that was filed against the IRS, and the level of concerns that were raised –much of our program has been on mute.
